The business has the following in place to support guests during pre-arrival, arrival and reception

- A tablet with text to voice or pen and paper at reception to aid in communication
- Picture Board at reception to aid in communication
- Lighting in the reception area is even and glare free

All registrations for artists, venues and our audience are online, however registrations can be taken face-to-face or over the phone; as can ticket purchases for audiences.

As an open access festival, Adelaide Fringe does no operate any venues.

The following steps are in place to ensure that people with fatigue related to their disability are not disadvantaged by long wait times: The Adelaide Fringe Box Office has a priority queue for all patrons with accessibility requirements. Notes taken at the point of ticket purchase can provide front of house staff with information about how patrons can be accommodated at the event.

Entry

- Glass doors are fitted with a visual sighting strip
- Door jams/doors are of a contrasting colour to surrounding walls
- Door handles are of a contrasting colour to the door
- Signage is written in a contrasting colour
- Signage is written in a Sans Serif font and use upper and lower case letters
- The entry door is a minimum of 850mm wide
- The entrance sill is less than 13mm
- The entrance door mats have a thickness less than 13mm and a width of 7500mm or greater

Internal Spaces

- Clear and unobstructed routes through and between buildings

- Any protruding or overhanging obstructions are at least 2meters above the floor or are protected
- Floor surfaces are hard or short pile carpet
- Seating is available for guests unable to stand for long periods
- All corridors greater than 900mm
- There is a quiet space for parents and children on the Autism Spectrum

There are two private meetings rooms in Adelaide Fringe HQ in which the lights can be dimmed to make a sensory-friendly zone.
